FEES:

This breeding is not to be sold or transferred and has to be used in the CURRENT breeding season. Should the Mare Owner fail to order semen or try to achieve a pregnancy during the current breeding season, this Agreement will be null and void.

1. The breeding fee is 3000 EURO for one (1) breeding

Plus 25 % Swedish VAT on all fees If Private costumer in EUROPE.
VAT free outside Europe or with a valid European VAT number

2. The breeding fee has to be paid upon signing of this contract to the following bank details:

3. Preparing of the semen/nitrogen: 100 EURO
4. Shipping costs: Depending of destination.
5. Health Certificate/Traces from Official veterinarian: 150 EURO
6. Eventually Re-breed fee, each extra dose 200 EURO

CONDITIONS:

1. This breeding contract entitles the **Mare Owner** to 1, one breeding to **MAGIC MAGNIFIQUE** with one breeding certificate being issued per contracted mare.
2. 1 breeding is 3 doses frozen semen included, 1 dose is 8 straws. 1 "dose" of frozen semen is defined as a single insemination unit, includes minimum 1 billion total sperm.
3. The semen was collected in the approved EU- Semen collection Center.
4. The stallion have been tested **NEGATIVE** for EVA and EIA, CEM, DOURINE and GLANDERS.
5. The frozen semen will be shipped in a Liquid Nitrogen "Dry Shipper" and has to send back directly to the **Stallion Owner** or the Agent when transferred the frozen semen.
6. Once the frozen semen arrives, it should be transferred rapidly to a nitrogen tank. Do not remove semen until ready to transfer the straws to the tank.

7. The **Stallion Owner** will supply frozen semen of the stallion concerned by this contract but does not guarantee the state of the semen starting from the moment it has been sent from the stallion station.
8. The **Mare Owner** is responsible for the correct handling of the semen and insemination of the mare.
9. In the event the contracted mare fails to conceive within three (3) heat cycles the **Stallion Owner or her Agent** reserves the right to require the contracted mare to be cultured or biopsied to determine breeding soundness.
10. The **Stallion Owner** will not be considered responsible for delayed delivery of the semen from the carriers.
11. Should the contracted mare become ill, injured or is otherwise unable to conceive a foal the **Mare Owner** may substitute the mare.

LIVE FOAL GUARANTEE:

1. In the event the contracted mare fails to conceive within three (3) heat cycles, with the 3 doses included, or the foal dies before 48 hours life, the **Mare owner** has the right to Re-breed the mare the following breeding season.

The **Mare owner** can in that case, buy extra doses frozen semen with the price of 200 EURO each dose. (Plus the eventually cost of paperwork, health certificate and shipping cost etc)

2. Re-breed rights shall be valid **ONLY** for the subsequent breeding season.
3. Should the foal be born dead or die before standing and nursing at 48 hours of birth, written statement from the **Mare Owners** licensed veterinarian stating the time and date of birth and the time and date of death shall be sent to the **Stallion Owner** within two (2) weeks of the foals death.
4. Should the stallion die or become unavailable and should semen at that time (fresh or frozen) no longer be available, **Stallion Owner** will no longer be responsible to fulfill this contract.

INDEMNITY:

This contract constitutes the entire agreement between both parties and may not be modified except in writing and agreed upon by both parties.

This contract cannot be sold or transferred to third part.

This Agreement shall be governed by and construed in accordance with the laws of Sweden.
