## **THE PARTIES HERETO AGREE AS FOLLOWS:**

This breeding is not to be sold or transferred and **must be used in the 2025 breeding season or during 2026**. If the Mare is not in foal during this period, the breeding contract is no longer valid.

### **1. FEES:**

#### **The breeding fee is 3.500, - euro**

Plus Swedish VAT (25%)

There is no VAT if you are outside Europe or have a valid European VAT-number.

**1a.** The breeding fee must be paid upon signing of this contract to the following bank details:

#### **1b. The breeding fee must be paid as follows:**

The breeding fee must be wired by Bank Transfer upon signing this contract and prior to shipment of semen. A separate invoice is sent upon signing the contract.

All amounts paid by the Mare owner shall not be refundable.

All shipping and semen handling cost are to be paid by the Mare Owner.

For faster handling send payment receipt to the Stallion owner.

The breeding fee is **3.500 Euro** plus Swedish VAT (25%)

*There is no VAT if you are outside Europe or have a valid European VAT-number.*

If the breeding will be provided by frozen semen the contract contains two (2) doses of frozen semen included.

If more doses are needed, the Mare Owner can buy extra doses of frozen semen.

#### **Fresh semen**

**1c.** Fresh semen collection fee: 150, - euro

**1d.** Handling/Health certificate/TRACES: 150, - euro

**1e.** Shipping costs: Depending on the destination.

#### **Frozen semen**

**1f.** Handling fee/Health certificate/TRACES Frozen semen: 300, - euro

**1g.** Extra doses of Frozen Semen: 300, - euro per dose

**1h.** Container rent for max. 14 days: 200, - euro + shipping cost back

**1i.** Shipping costs: **Depending on the destination.**

**1j.** Invoices and all costs from the list above (1a-j) are subject to 25% Swedish VAT. *(No VAT if you are outside EU or have a valid European VAT-number)*

**1k.** No semen will be sent unless all previous invoices have been settled.



11. No breeding certificate will be issued unless ALL fees have been paid in full.

## 2. CONDITIONS:

2a. This breeding contract entitles the **Mare Owner** to one (1) breeding to **MEDAN AL SHAQAB** with one (1) breeding certificate being issued per contracted mare.

**One breeding of Frozen semen is provided with 2 doses included and every dose contains 6 straws.**

2b. In the event the contracted mare fails to conceive within three (3) heat cycles the **Stallion Owner** reserves the right to require the contracted mare to be cultured or biopsied to determine breeding soundness. The **Stallion Owner** also reserves the right to refuse service to any mare upon detection of an infectious and/or contagious disease. In the event of such discontinuance, the **Mare Owner** is obligated to substitute another mare to fulfill the terms of this agreement.

2c. Should the contracted mare become ill, injured or is otherwise unable to conceive a foal the **Mare Owner** may substitute the mare, after notification to Stallion Owner.

**This breeding cannot be resold or provided to any other party.**

2d. The **Stallion Owner** shall provide semen from the stallion identified in this contract and make no guarantee of the condition of the semen once the semen has left semen storage facility. The Mare Owner shall be responsible for semen storage, proper handling, and insemination into the mare.

2e. The **Stable Owner** will not be considered responsible for delayed delivery of the semen from the carriers. In case the shipment of the semen gets lost or is delayed by the carrier, the **Mare Owner** will have to refuse the package once it eventually gets delivered, so that the Stable Owner will not be responsible for the payment of the shipment. Should the **Mare Owner** accept a late delivery, they will have to pay the semen collection, health certificate & handling, and shipment. The costs of collection, handling and Health Certificate/TRACES will have to be covered by the **Mare Owner** even if the shipment is lost or delayed.

## 3. RE-BREED CONDITIONS & LIVE FOAL GUARANTEE:

3a. The Stallion Owner guarantees a return breeding within this breeding season 2025, or the following season of 2026, either for the contracted mare or an approved substitute. After this period the breeding contract is no longer valid.

3b. The Mare Owner is obligated to notify the Stallion Owner of conceive within 60 days of season end to be eligible to rebreed. Failure to have the mare examined or failure to notify the Stallion Owner of the result shall automatically render the live foal guarantee and applicable rebreeding rights of the Mare Owner null and void.

3c. Should the foal be born dead or die before standing and nursing without assistance for 48 hours of birth, written statement from the Mare Owners licensed veterinarian stating the time and date of birth and the time and date of death shall be sent to the Stallion Agent within two (2) weeks of the foal's birth/death.

3d. Re-breed rights are only valid this season and the upcoming season. (2025-2026)

3e. Should the stallion die, be sold or become unavailable and should semen (fresh or frozen) no longer be available, Stallion Owner will no longer be responsible to fulfill this contract.



#### **4. REGULATIONS AND REQUIREMENTS OF REGISTRY:**

**4a.** The Mare Owner assumes all responsibility for following the regulations or requirements that may be imposed by any breed registry. It is the Mare Owner's sole responsibility to follow all the necessary requirements and time limits put in place by the Registries to register the foal resulting from this breeding agreement.

**4b.** The Mare Owner must inform the Stallion Owner **the same year** the mare is confirmed pregnant to be able to be assigned a breeding certificate. If the Mare Owner doesn't report confirmed pregnant latest 31 of December the year the mare is in foal, to assign a breeding certificate a late fee of 250 Euro will be added to receive the breeding certificate.

#### **5. INDEMNITY:**

**5a.** Sweden Arabian Stud, as **Stallion Owner**, agents, employees, veterinarians shall not be liable for any sickness, disease, theft, or injury which may be suffered by the contracted mare and/or resulting foal and/or semen during the breeding period of the contracted mare.

**5b.** This contract constitutes the entire agreement between both parties and may not be modified except in writing and agreed upon by both parties.

#### **6. JURISDICTION:**

**6a.** This agreement shall be a binding agreement once executed by both parties. This agreement and all matters collateral thereto shall be governed by the laws of Sweden.
